Responsibility

In undertaking the Evolutionary Manifesting Course, I understand that any Evolutionary Manifesting reading and homework/follow-up actions I may do for myself (as a result of or as part of my studies) are not meant to take the place of professional advice from an expert such as my mental health professional, tax advisor, doctor, naturopath, accountant, or any other professional.

I understand that the health practices and procedures mentioned in the Evolutionary Manifesting Course (which may be undertaken with the objective of building the energy field) are not to be done without advice from a health professional.

I understand that my results and whatever may arise as a consequence of using the course materials, are exclusively my responsibility.

Confidentiality

The Evolutionary Manifesting Course features both private client case histories and sensitive information regarding the author's past experiences.

I understand that such information is by and of itself of a confidential nature and I agree not to discuss it with any person who is not enrolled as a student in the Evolutionary Manifesting Course.

In addition, I agree to keep strictly confidential any information shared by students in the course forums.

Presentation of Services

The Evolutionary Manifesting modality is centred around one core principle, which is that conscious creators often struggle to manifest their desired outcomes, owing to the fact that:

- (i.) Many carry karmic complexes within their subtle energy bodies; and
- (ii.) Many popular healing modalities, when undertaken with the aim of resolving a karmic complex, only partially resolve these karmic complexes, if at all.

The Evolutionary Manifesting modality teaches that specific techniques are the most effective in fully resolving karmic complexes, and that the key to resolving a complex lies in choosing one's healing modality strategically at the moment of attempted complex resolution.

As a result, I accept that if I offer/suggest other types of therapies or techniques (ones that do not align with the Evolutionary Manifesting teachings) in an attempt to assist clients in resolving complexes, I am no longer practising the Evolutionary Manifesting modality as it is taught.

In such a scenario, if I choose to call myself an Evolutionary Manifesting practitioner or mention the Evolutionary Manifesting modality in my marketing and sales materials, I am also required to state clearly and prominently that I do not fully use the Evolutionary Manifesting protocol nor adhere fully to its principles.

In addition, I understand that even if I sign up for the Professional version of the program, I am not eligible for listing in the practitioner directory if I am deviating from the six core Evolutionary Manifesting Principles (Appendix I) in any significant way in the course of my client work.

Respect of Intellectual Property

The Evolutionary Manifesting readings that are taught in the course are designed to be passed on verbally, as telephone, online or 'in-person' readings.

In light of this, in undertaking the Evolutionary Manifesting Course, I agree that I am ONLY purchasing instructions to do Evolutionary Manifesting readings (to be delivered in person, by telephone or online) along with the knowledge required to follow such instructions.

I fully understand that in enrolling in the Evolutionary Manifesting Course, my purchase does not include a licence to use Anna Sayce's written intellectual property (which comprises, but is not limited to, the Evolutionary Manifesting written course materials) in an email reading.

I understand that I will only have a licence to use Anna Sayce's Evolutionary Manifesting written materials in the context of an email reading (i) if I am eligible for an annual licence to use the Evolutionary Manifesting email templates¹ and (ii) if I choose to purchase such an annual licence.

¹ Professional Evolutionary Manifesting students and former Akashic Record Reading Program students are eligible to purchase a licence to use the Evolutionary Manifesting email templates.

I understand that the only documents I may share with clients are the ones clearly designated for this purpose in the course materials.

I also accept that it is prohibited to share, post online or disseminate the course materials.

I understand that such violation of copyright law would result in (but would not be limited to) the following steps:

(i.) Immediate removal from the Evolutionary Manifesting Course, with no refund; and

(ii.) Pursuit through the available legal avenues for loss of income, any other damages (where applicable) along with any legal fees expended through such a process that may be undertaken by the author.

APPENDIX I

The **Evolutionary Manifesting Principles that Professional practitioners must adhere to in their practice of the Evolutionary Manifesting modality in order to be eligible for inclusion in the Practitioner Directory are as follows:*

(i.) Many conscious creators carry karmic complexes within their subtle energy bodies and manifest their lives accordingly;

(ii.) Many popular healing modalities, despite having value in a variety of ways, do not fully resolve such karmic complexes;

(iii.) Revision/rescripting modalities and forms of past life regression that involve elements of rescripting, soul retrieval and/or bodywork are most effective for fully neutralising karmic complexes;

(iv.) The '6 downstream auric issues' should be cleared alongside (or after) the work done to neutralise the karmic complex; and not beforehand;

(v.) Human beings receive and process energy from Source on a nightly basis, unconsciously and automatically squandering some while usually conserving a specific amount within the subtle energy field for use during a 24 hour period. The remaining energy is used for (conscious and/or unconscious) creation.

The amount of energy usually held within the subtle energy field corresponds exactly to a person's capacity to consciously create their desired outcome. The human energy field must have sufficient energy available within it, either for manifesting a new desired outcome or for karma clearing, according to the aim of the conscious creator. If energy is lacking, it must be built before the conscious creator's aim can be achieved; and

(vi.) The building of the energy field will occur as a result of using conscious creation techniques and 'healthy living' practices. The process is further enhanced by following the seven 'rules of energy economics', as taught in the Evolutionary Manifesting Course.

Inconsequential deviations from the Evolutionary Manifesting protocol (such as changing the order of steps within the protocol or omitting minor parts of it) are permissible for Professional students who wish to be included in the Practitioner Directory.

Significant deviations from the Evolutionary Manifesting Principles (such as using modalities which are known to be less successful for clearing karmic complexes when the client is ready to clear their complex) would preclude inclusion within the Practitioner Directory among Professional students who wish to be featured in the Directory upon completion of their studies.
